RELEASE AND WAIVER OF ALL LIABILITY AND HOLD-HARMLESS AGREEMENT FOR MINOR CHILDREN - MUST BE COMPLETED BY PARENT AND/OR LEGAL GUARDIAN

I agree that in order for my minor child to enter NTR Offroad, LLC (hereinafter NTR Offroad) for any and all purposes, including but not limited to: (1) operating or riding in any and all types of vehicles; (2) participating in or observing NTR Offroad events and/or competitions; (3) officiating in NTR Offroad events; or (4) working for NTR Offroad or its subcontractors or vendors, I, the undersigned, on behalf of myself and my personal representatives, heirs and assigns hereby agree to the following:

I, on behalf of my child, hereby release and permanently and forever discharge NTR Offroad, its land owners, agents, officers, managers, employees, volunteers, sponsors and subcontractors from any and all liability for acts or omissions, including negligent acts or omissions, causing damage, loss, injury or death to me or my child while participating in or observing any and all activities at any time at NTR Offroad.

I do hereby agree to, immediately upon entering NTR Offroad and continuously thereafter, inspect all areas of NTR Offroad I occupy, and if I believe anything is unsafe, my child and I will immediately leave NTR Offroad's premises and notify NTR Offroad management of the condition I believe to be unsafe. I agree that my child's participation and activities within NTR Offroad shall constitute my acknowledgement that I have inspected NTR Offroad's premises and found them to be reasonably suited for my child's purposes in using the premises. I am familiar with the activities that occur at NTR Offroad, and my child is physically and mentally able to participate in such activities. I understand that each of these activities presents risks to my child of damage, loss, injury, illness and death. Having this knowledge, I expressly assume such risks on my child's behalf. I also understand that each of these risks presents risks of damage or destruction of my child's property, and with that knowledge, I expressly assume such risks on my child's behalf.

I hereby agree to indemnify and hold harmless NTR Offroad, its land owners, agents, officers, managers, employees, volunteers, sponsors and subcontractors from any and all liability, costs, including attorneys fees or loss, **including liability for negligence arising in conjunction with or resulting from my child's participation in any and all activities at NTR Offroad** or from my child's presence on NTR Offroad's premises. I acknowledge that I have read and understand NTR Offroad's Park Rules, and I agree to comply and ensure my child's compliance with each of them while either of us are present on NTR Offroad premises. I intend this Release and Waiver of Liability and Hold Harmless Agreement to be enforced in accordance with the laws of the State of Oklahoma and that the proper jurisdiction and venue will lie only in Bryan County, Oklahoma and waive jurisdiction and venue in any other county or state. I intend this document to be as broad and inclusive as permitted by law. If any portion of this document is found to be invalid for any reason, the remainder of the document shall continue to remain in full force and effect and shall continue to be binding.
